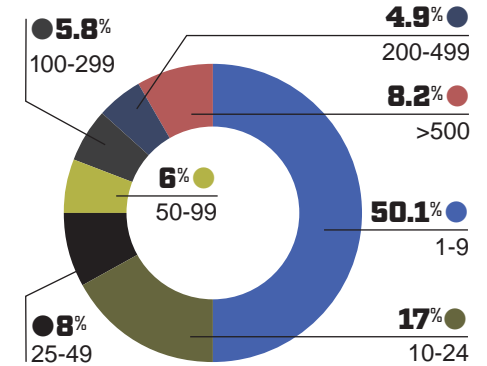

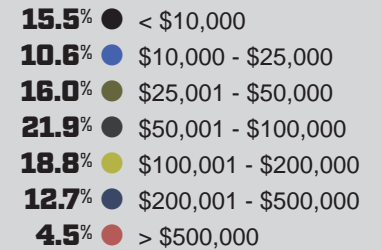


HOW MANY RMIS USERS DOES YOUR ORGANIZATION HAVE?

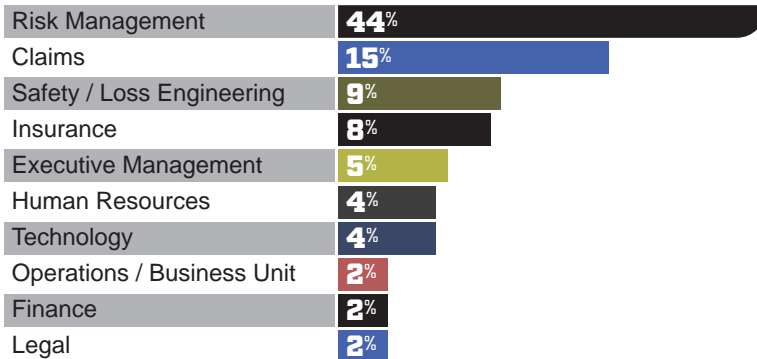


WHAT IS YOUR ANNUAL COST OF RMIS?

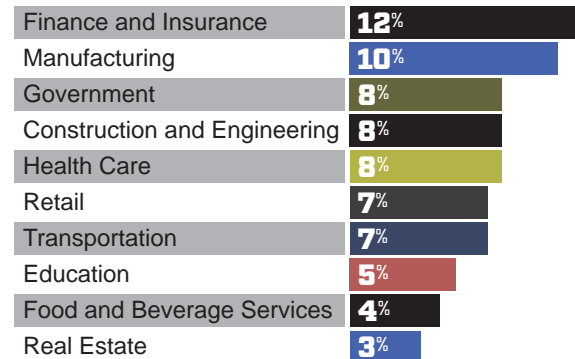

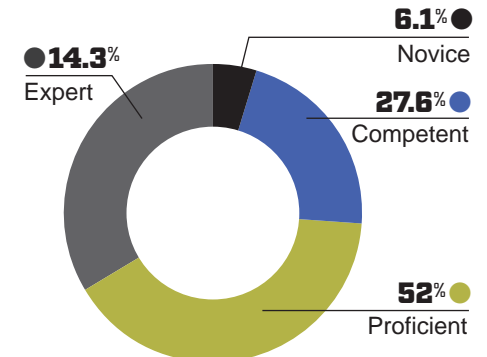

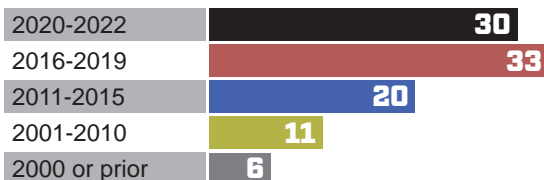

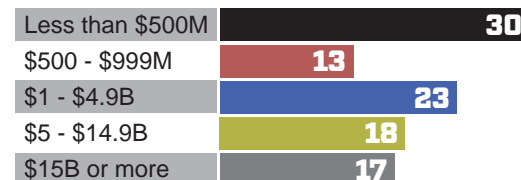
HOW WOULD YOU DESCRIBE YOURSELF AS A USER?

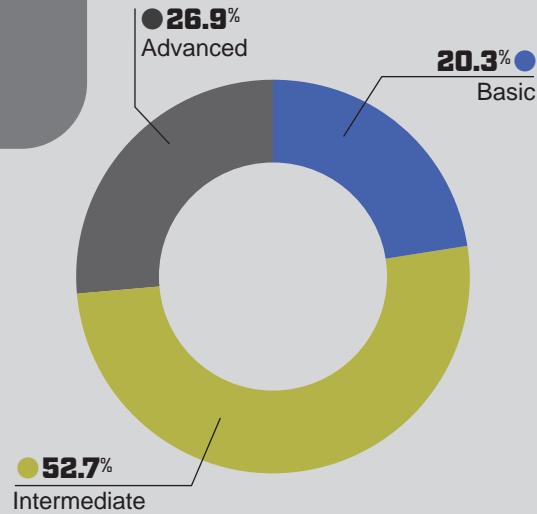

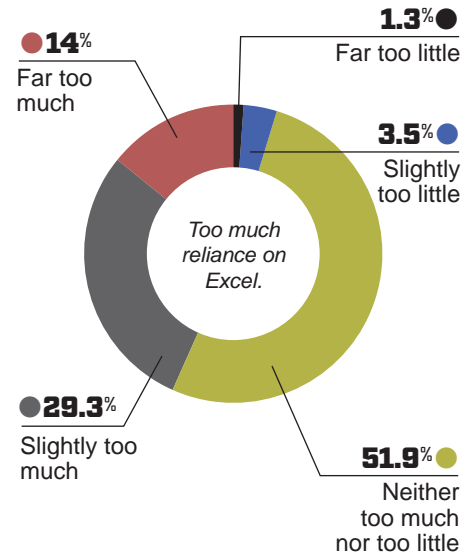

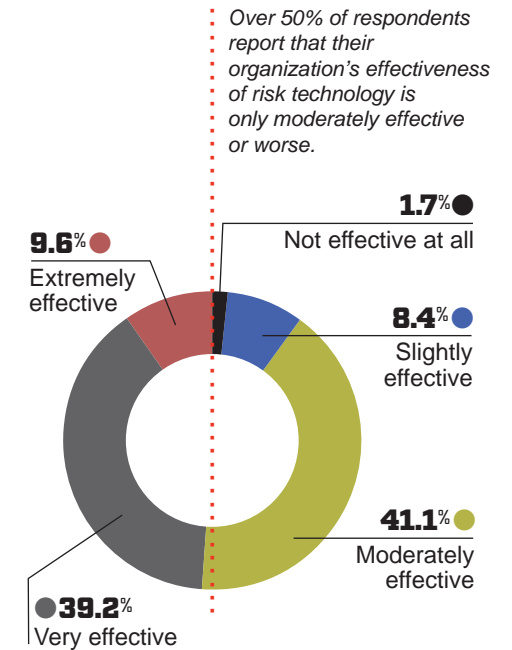
HOW WOULD YOU DESCRIBE YOUR ORGANIZATION'S USE OF RMIS?



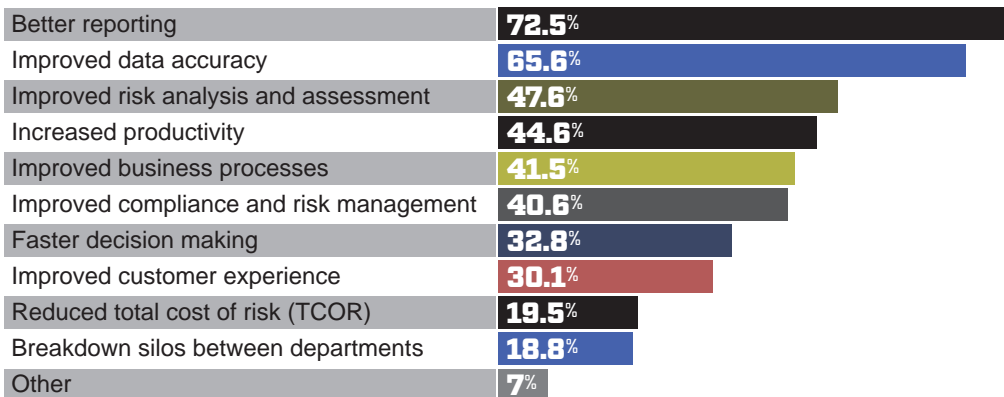
HOW MUCH DO YOU RELY ON EXCEL TO PERFORM YOUR FUNCTION?



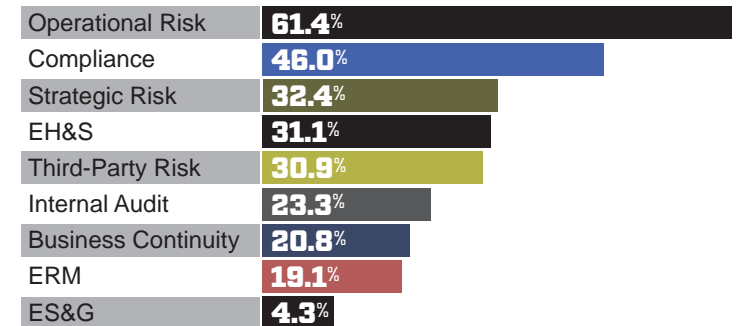
HOW EFFECTIVE IS YOUR ORGANIZATION'S RISK TECHNOLOGY?

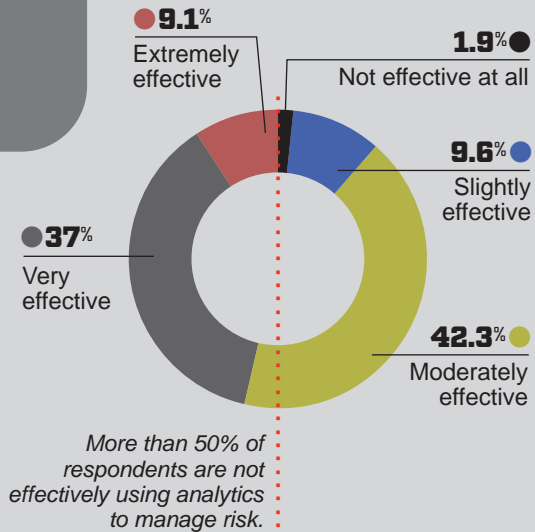

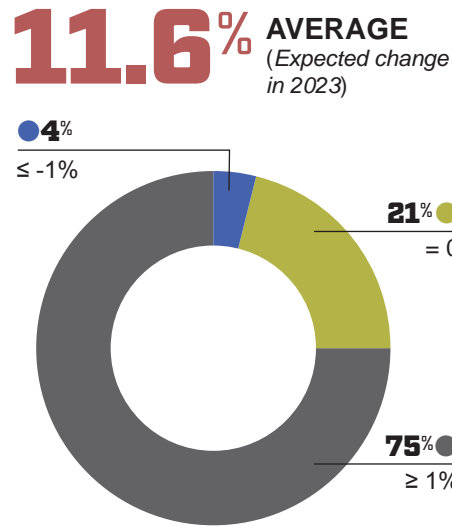

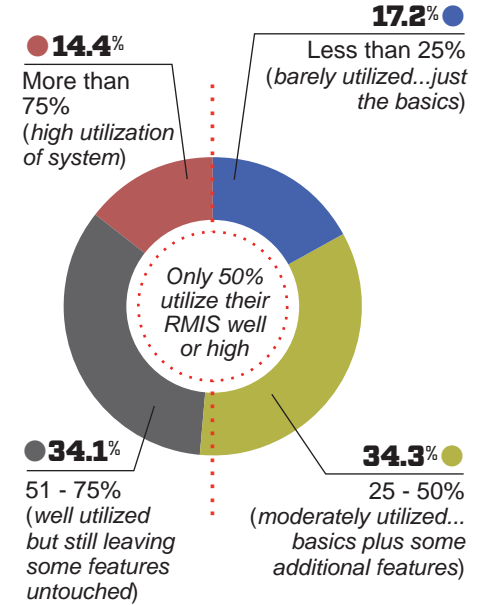
HOW EFFECTIVE IS YOUR USE OF DATA AND ANALYTICS TO MANAGE RISK?

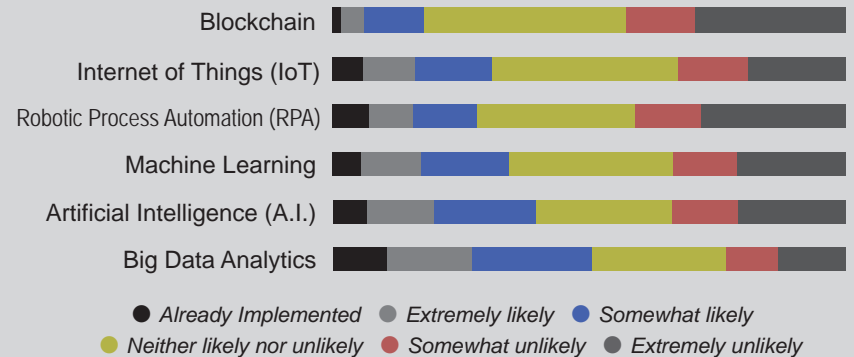
